

II. Operational situation during the year

1. Business and Production Activities

The weather situation in 2024 is complicated and contradictory: From January to April, there was severe drought, the water level of rivers and streams was low, in May, the rainfall improved, from June to early October, the entire Northwest region continuously had localized heavy rain, typically the rain from the night of September 8-10 (due to the influence of super typhoon Yagi) caused severe flooding and landslides in the Northwest provinces, especially Lao Cai, which greatly affected the power generation of hydropower plants, including Ngoi Phat. From November to December 2024, the rainfall was much lower than the average of many years, leading to many difficulties in power generation.

1.1. Production Operation Situation

- The plant operates stably and safely with all 4 units, without subjective incidents, reaching capacity when there is enough water; good coordination with EVN dispatching, so it can operate continuously, optimize market prices, reduce self-consumed electricity costs, increase equipment life...
- Although storm Yagi in September caused serious consequences, thanks to the Company's proactiveness and efforts to prevent it, the Company's assets were ensured to be safe, there were no human losses, the damage was overcome and power generation resumed after 10 days at maximum capacity.
- The results of commercial electricity output in 2024 are as follows:

- Regarding electricity market activities: The Company's participation rate in the electricity market from 2023 to 2024 is stable at 2%. Although the electricity output did not reach expectations, the profit from participating in the electricity market in 2024 reached 3,354 million VND compared to the plan of 2,000 million VND.

1.2. Maintenance, repair, troubleshooting and other work:

- Regarding maintenance and repair, the Company completed the maintenance of the entire equipment system of the head dam area, restored the backup TGB drive, generators H1-H2-H3; compensated/cleared the corridor of the power line, the blocking station and other production facilities; dredged sediment after floods at the downstream discharge channel, overcame traffic landslides on routes VH1-VH2, Ban Xeo, San Bang - Muong Vi and works after typhoon No. 3 (Yagi); completed the overhaul of generator H2 ahead of schedule.
- Regarding technical innovation and technology optimization: The Company has implemented the work according to plan, completed the upgrade of the DSC system, SCADA system of H1-H2-H3 units, deployed the HNT system from January 2024, assessed internal ISO, renovated and improved some equipment, built a method of sharing hydrological information on the Ngoi Phat river cascade hydropower system...
- Regarding safety assurance, fire prevention, and natural disaster prevention: The Company has completed the Labor Safety and Hygiene Committee, the Natural Disaster Prevention and Search and Rescue Committee, established a grassroots fire prevention team; inspected high-safety equipment and fire prevention equipment on time.



- Comments on the labor structure by classification:

Northern Electricity Investment and Development Joint Stock Company 2 is an enterprise established under the Enterprise Law, is the Investor unit with the task of managing and operating the Ngoi Phat Hydropower Plant and the expanded Ngoi Phat Hydropower Plant to ensure safety, stability, efficiency and reliability.

- + The reason (characteristics of the industry) leading to the above structure: The main task of the Company is to ensure the stable, safe, secure and reliable operation of the Plant. Due to the Company's specific nature of operating a hydropower plant, the above labor structure is reasonable.
- + What impact does the above structure have on employee policies: The compact and streamlined structure of the management and operation apparatus creates conditions for employees to promote their individual roles in assigned work, on the other hand, the Company's leaders will have the opportunity to pay careful attention to policies and regimes for employees, creating conditions for employees to feel secure in their work and contribute to the Company's long-term service.

- Policy for employees:

❖ Salary and bonus policy:

- + Introduction to the Company's salary scale system: The Company was established under the Enterprise Law and all policies for employees in the Company are applied according to the current provisions of the Labor Code. The salary scale system and salary policy are applied according to the provisions of Decree 49/2013/ND-CP and Circular 17/2015/TT-BLDTBXH dated April 22, 2015 of the Government and the salary scale developed by the Company shall be applied from January 1, 2017.
- + Allowances for non-specialized members of the Board of Management and the Inspection Committee are submitted by the Company to the annual General Meeting of Shareholders for approval at an appropriate and guaranteed level.
- + The Company's payroll is built according to the guidance in Decree 49/2013/ND-CP dated May 14, 2013 and Circular 17/2015/TT-BLDTBXH dated April 22, 2015 of the Government.

III. Report and assessment of the Board of Directors

1. Assessment of production and business activities results

a. Production and business results in 2024:

- In general, hydrological conditions in 2024 are more favorable than in 2023, however, the weather situation in 2024 is complicated and contradictory: From January to April, there was severe drought, water levels in rivers and streams were low, in May, rainfall improved, from June to early October, the entire Northwest region continuously had localized heavy rains, typically the rain from the night of September 8-10 (due to the influence of super typhoon Yagi) caused severe floods and landslides in the Northwest provinces, especially Lao Cai, which greatly affected the power generation of hydropower plants, including Ngoi Phat. From November to December 2024, rainfall is much lower than the average of many years, leading to many difficulties in power generation.
- The average water flow to Ngoi Phat reservoir in 2024 is 27.84 m³/s, equal to 139.2% of 2023 (20 m³/s) and equal to 102.34% of the cumulative average of the years from 2016-2023 (27,203 m³/s).

b. The Company's achievements:

- The plant has been in operation for 10 years, so the management, operation and repair team has gained a lot of experience with increasingly high skills, so there are regular improvements to improve operational reliability, improve power generation efficiency, etc.
- The plant is located in a favorable geographical location and natural conditions, in the upstream area supplying electricity to the Northern region, so the load demand is high and located at the bottom of Ngoi Phat stream, so it can take advantage of water sources from the reservoirs of the upper-level hydropower plants, contributing to maintaining stable electricity production output of the plant.
- Management and operation work is constantly improved and is actively supported by major shareholders Vinaconex and Toyota Tsusho.

2. Financial situation

The Company maintains a regular financial balance, fully meeting the financial needs to pay for production and business costs, and overcome the consequences of storms and floods. In 2024,

IV. General assessment of the Board of Management on the Company's operations

1. Assessment of the Board of Management on the Company's operations

1.1. On the organization and operation of the Board of Management

- In 2024, the BOM held 14 Board meetings and 01 General Meeting of Shareholders, issued 19 Resolutions/Decisions (at direct meetings or by requesting written opinions) to perform the function of managing the Company's operations and directing the Executive Board in performing the production and business tasks assigned by the General Meeting of Shareholders. The specific contents of the Resolutions/Decisions are fully presented in Section V. Corporate governance of this report.

- The BOM directed the successful organization of the Annual General Meeting of Shareholders, issued Resolutions/Decisions as a basis for the Executive Board to implement.
- Supervise and direct the Board of Directors to operate production and business activities in 2024 according to the Resolution of the 2024 Annual General Meeting of Shareholders. Despite many difficulties due to complicated weather and natural disasters, in 2024, 104.1% of the profit plan approved by the General Meeting of Shareholders was completed.

1.2. Assessment of the Company's production and business results in 2024

- 2024 is a year with complex weather and natural disasters, with a large difference between the rainy season and the dry season compared to the average of many years, leading to many difficulties in power generation.
- The plant operates stably and safely, without subjective incidents, reaching capacity when there is enough water, total loss, self-use in 2024 reaches 4.39%. Good coordination with EVN dispatchers should be operated continuously, optimizing market prices, reducing self-consumption electricity costs, increasing equipment life...
- In early September, storm No. 3 (Yagi) swept into the North, causing serious impacts on the Plant, with strong floods flowing into the lake along with mud, trash, and trees, forcing the Plant to stop generating electricity for units H1-H2-H3 for 236 hours (nearly 10 days) and unit H4 for 92 hours (nearly 4 days) to repair damage after the storm. After being repaired, all 4 units were in operation and generating electricity again.
- Regarding electricity market work: The Company exceeded electricity market revenue by 3.354/2 billion VND.
- Regarding maintenance and repair work: Doing a good job of regular maintenance and repair of equipment, promptly handling incidents and fixing equipment defects: Completing the overhaul of unit H2 and minor overhaul of unit H1; Completed replacement of the flap gasket, repair of the main Dam's bow valve, repair and restoration of the spare TGB bearing, replacement of the downstream valve gate gasket, clearing and compensation of the 110KV, 35KV transmission line corridor, and the 175-way blocking station... to meet quality, technical and progress requirements, ensuring stable and reliable operation.
- Regarding the improvement work: Completed upgrading the DSC/SCADA system of the H1-H2-H3 units; Completed installation and commissioning of the OPU oil pipeline system; Installed additional cooling fan system to control the temperature of the DVR unit H4; Upgraded the upstream water level monitoring system, integrated into the Scada system; Upgraded the machine room crane; Improved the hot backup heat exchanger of the GLOP cooling system of the H4 unit; Building a method of sharing hydrological information on the Ngoi Phat river cascade hydropower system...

General assessment: Despite many difficulties due to the complicated weather and natural disaster situation, with the efforts and striving of the Executive Board and the Company's staff, along with the wise and timely leadership of the Board of Management and major shareholders, in 2024, NED12 Company completed 104.1% of the profit plan and 100% of the dividend plan assigned by the General Meeting of Shareholders.

2. Assessment of the Board of Management on the performance of the Company's Board of Directors

- In 2024, the Executive Board, headed by the General Director, conducted the Company's production and business activities in compliance with the provisions of law, the Charter, Internal Regulations and Business Registration.
- The members of the Executive Board are experienced, competent, qualified and responsible. The General Director directed the full and timely implementation of the Resolutions and Decisions of the Board of Management; built a transparent, drastic working mechanism, with specific delegation of authority so that each member can maximize their initiative, creativity and responsibility in the assigned work areas.
- The General Director held regular weekly/monthly meetings with the Deputy General Directors, Chief Accountant, Heads/Deputy Heads of Departments, and Leaders of Ngoi Phat Hydropower Plant; The General Director directs the daily work of the Company and implements the decisions and resolutions of the Board of Management and the General Meeting of Shareholders thoroughly - resolutely - promptly to complete the assigned plan.
- Financial activities, managing cash flow of revenue and expenditure effectively, transparently, meeting production and business requirements, not allowing overdue debts with credit institutions.
- Maintaining labor discipline, focusing on management to improve productivity and work efficiency; arranging and optimizing human resources, reducing costs, improving production and business efficiency of the Company.
- Maintaining care for the lives of employees, paying salaries and bonuses, paying insurance and social benefits fully and promptly, implementing effective welfare policies such as supporting vacation expenses, periodic health check-ups, complying with regulations on the working environment, performing social responsibility with the community in Ban Vuoc commune, Bat Xat district and social programs launched by Lao Cai province.
- Shareholder relations and information disclosure continue to be well maintained.
- The activities of the Company's Party Committee and Trade Union are well maintained.

3. Plans and orientations of the Board of Management

Based on the results of production and business from 2015 to 2024 and the spirit of solidarity and unanimity of the Company's leadership and employees, the Board of Management has identified a number of key tasks to be carried out in 2025 as follows:

- Strongly innovate management and operation, thinking, dynamism, promote collective intelligence;
- Focus on operating the Ngoi Phat hydropower plant cluster effectively, ensuring system safety, and making technical improvements to operate the plant most effectively;
- Develop cooperative relationships with partners of Vietnam Electricity Group (EVN), credit institutions, and power generation enterprises in the area to operate Ngoi Phat Hydropower Plant effectively, ensuring safety and reliability;

- Continue to fulfill corporate social responsibility.

INDEPENDENT AUDITORS' REPORT

We have audited the accompanying financial statements of Northern Electricity Development and Investment Joint Stock Company No. 2 ("the Company"), as prepared on 21 February 2025 and set out on pages 5 to 32, which comprise the balance sheet as at 31 December 2024, and the income statement and the cash flow statement for the year then ended and the notes thereto.

Management's responsibility



NOTES TO THE FINANCIAL STATEMENTS
as at 31 December 2024 and for the year then ended

1. CORPORATE INFORMATION

Northern Electricity Development and Investment Joint Stock Company No. 2 ("the Company") is a shareholding company incorporated under the Law on Enterprise of Vietnam pursuant to Investment Certificate No. 12121000084 dated 10 April 2008 issued by the Lao Cai Planning and Investment Department and amended Investment Registration Certificates, with the latest being the 3rd amendment on 25 April 2015. The Company also obtained Business Registration Certificate No. 5300215527 dated 6 May 2004, with the latest being the 12th amendment on 30 May 2023.

As at 22 July 2010, the Company completed the registration to be listed as ND2 on the Hanoi Stock Exchange.

The current principal activity of the Company is producing electricity.

The head office of the Company is located at Ban Sang village, Ban Vuoc commune, Bat Xat district, Lao Cai province and its representative office is located on the 7th floor, Vinaconex Diamond, No.459C, Bach Mai street, Truong Dinh ward, Hai Ba Trung district, Hanoi, Vietnam.

The total number of the Company's employees as at 31 December 2024 is 72 (31 December 2023: 79).

2. BASIS OF PREPARATION

2.1 *Accounting standards and system*

The financial statements of the Company, which are expressed in Vietnam dong ("VND"), are prepared in accordance with Vietnamese Enterprise Accounting System and other Vietnamese Accounting Standards issued by the Ministry of Finance as per:

- ▶ Decision No. 149/2001/QD-BTC dated 31 December 2001 on the Issuance and Promulgation of Four Vietnamese Standards on Accounting (Series 1);
- ▶ Decision No. 165/2002/QD-BTC dated 31 December 2002 on the Issuance and Promulgation of Six Vietnamese Standards on Accounting (Series 2);
- ▶ Decision No. 234/2003/QD-BTC dated 30 December 2003 on the Issuance and Promulgation of Six Vietnamese Standards on Accounting (Series 3);
- ▶ Decision No. 12/2005/QD-BTC dated 15 February 2005 on the Issuance and Promulgation of Six Vietnamese Standards on Accounting (Series 4); and
- ▶ Decision No. 100/2005/QD-BTC dated 28 December 2005 on the Issuance and Promulgation of Four Vietnamese Standards on Accounting (Series 5).

Accordingly, the accompanying financial statements, including their utilization are not designed for those who are not informed about Vietnam's accounting principles, procedures and practices and furthermore are not intended to present the financial position and results of operations and cash flows in accordance with accounting principles and practices generally accepted in countries other than Vietnam.

2.2 *Applied accounting documentation system*

The Company's applied accounting documentation system is General Journal System.

2.3 *Fiscal year*

The Company's fiscal year applicable for the preparation of its financial statements starts on 1 January and ends on 31 December.

2.4 Accounting currency

The financial statements are prepared in VND which is also the Company's accounting currency.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

3.1 Cash and cash equivalents

Cash and cash equivalents comprise cash on hand, cash at banks and short-term, highly liquid investments with an original maturity of not more than three months that are readily convertible into known amounts of cash and that are subject to an insignificant risk of change in value.

3.2 Inventories

Inventories are measured at their historical costs. The cost of inventories comprise costs of purchase, costs of conversion (including raw materials, direct labor cost, other directly related cost, manufacturing general overheads allocated based on the normal operating capacity) incurred in bringing the inventories to their present location and condition.

In case the net realizable value is lower than the original price, it must be calculated according to the net realizable value.

Net realizable value ("NRV") represents the estimated selling price in the ordinary course of business less the estimated costs to complete and the estimated costs necessary to make the sale.

The Company uses perpetual inventory method to record inventory including raw materials, tools and supplies with the weighted average method.

Provision for obsolete inventories

An inventory provision is created for the estimated loss arising due to the impairment of value (through diminution, damage, obsolescence, etc.) of inventories owned by the Company, based on appropriate evidence of impairment available at the balance sheet date.

Increases or decreases to the provision balance are recorded into the cost of goods sold in the income statement. When inventories are disposed because of being expired, obsolescence, damage or become useless, the difference between the provision previously made and the historical cost of inventories are included in the income statement.

3.3 Receivables

Receivables are presented in the financial statements at the carrying amounts due from customers and other debtors, after provision for doubtful debts.

The provision for doubtful debts represents amounts of outstanding receivables at the reporting date which are doubtful of being recovered. Increases or decreases to the provision balance are recorded as general and administrative expenses in the income statement. When doubtful debts are determined as unrecoverable and are written off, the differences between the provision for doubtful debts previously made and historical cost of receivables are included in the income statement.

3.4 Tangible fixed assets

Tangible fixed assets are stated at cost less accumulated depreciation.

The cost of a tangible fixed asset comprises of its purchase price and any directly attributable costs of bringing the tangible fixed asset to working condition for its intended use.

Expenditures for additions, improvements and renewals are added to the carrying amount of the assets and expenditures for maintenance and repairs are charged to the income statement as incurred.

When tangible fixed assets are sold or retired, any gain or loss resulting from their disposal (the difference between the net disposal proceeds and the carrying amount) is included in the income statement.

3.5 Leased assets

The determination of whether an arrangement is, or contains a lease is based on the substance of the arrangement at inception date and requires an assessment of whether the fulfilment of the arrangement is dependent on the use of a specific asset and the arrangement conveys a right to use the asset.

A lease is classified as a finance lease whenever the terms of the lease transfer substantially all the risks and rewards of ownership of the asset to the lessee. All other leases are classified as operating leases.

Where the Company is the lessee

Rentals under operating leases are charged to the income statement on a straight-line basis over the lease term.

3.6 Depreciation

Depreciation of tangible fixed assets are calculated on a straight-line basis over the estimated useful life of each asset as follows:

Buildings and structures	6 - 50 years
Machinery and equipment	3 - 20 years
Means of transportation	6 - 10 years
Office equipment	1 - 5 years

3.7 Borrowing costs

Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Borrowing costs are recorded as expense during the year in which they are incurred.

3.8 Prepaid expenses

Prepaid expenses are reported as short-term or long-term prepaid expenses on the balance sheet and amortised over the period for which the amounts are paid or the period in which economic benefits are generated in relation to these expenses.

3.9 Payables and accruals

Payables and accruals are recognised for amounts to be paid in the future for goods and services received, whether or not billed to the Company.

3.10 Foreign currency transactions

Transactions in currencies other than the Company's reporting currency of VND are recorded at the actual transaction exchange rates at transaction dates which are determined as follows:

- ▶ Transactions resulting in receivables are recorded at the buying exchange rates of the commercial banks designated for collection;
- ▶ Transactions resulting in liabilities are recorded at the selling exchange rates of the commercial banks designated for payment;
- ▶ Capital contributions are recorded at the buying exchange rates of the commercial banks designated for capital contribution; and
- ▶ Payments for assets or expenses without liabilities initially being recognised is recorded at the buying exchange rates of the commercial banks that process these payments.

At the end of the period, monetary balances denominated in foreign currencies are translated at the actual exchange rates at the balance sheet dates which are determined as follows:

- ▶ Monetary assets are translated at buying exchange rate of the commercial bank where the Company conduct transactions regularly; and
- ▶ Monetary liabilities are translated at selling exchange rate of the commercial bank where the Company conduct transactions regularly.

All foreign exchange differences incurred are taken to the income statement.

3.11 Appropriation of net profits

Net profit after tax (excluding negative goodwill arising from a bargain purchase) is available for appropriation to investors/shareholders after approval by the appropriate level of authority/in the annual general meeting, and after making appropriation to reserve funds in accordance with the Company's Charter and Vietnam's regulatory requirements.

The Company maintain the following reserve funds which are appropriated from the Company's net profit as proposed by the Board of Directors and subject to approval by shareholders at the annual general meeting.

Bonus and welfare fund

This fund is set aside for the purpose of pecuniary rewarding and encouraging, common benefits and improvement of the employees' benefits, and presented as a liability on the balance sheet.

3.12 Revenue recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable, excluding trade discount, rebate and sales return. The following specific recognition criteria must also be met before revenue is recognised:

Sale of electricity

Sale of electricity is recognised based on monthly reconciliation and confirmation of output volume between buyer and seller, at the price as stipulated in the power purchase agreement.

Interest

Revenue is recognised as the interest accrues (taking into account the effective yield on the asset) unless collectability is in doubt.

3.13 Taxation

Current income tax

Current income tax assets and liabilities for the current and prior years are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted as at the balance sheet date.

Current income tax is charged or credited to the income statement, except when it relates to items recognised directly to equity, in which case the current income tax is also dealt with in equity.

Current income tax assets and liabilities are offset when there is a legally enforceable right for the Company to set off current tax assets against current tax liabilities and when the Company intends to settle its current tax assets and liabilities on a net basis.

Deferred tax

Deferred tax is provided using the liability method on temporary differences at the balance sheet date between the tax base of assets and liabilities and their carrying amount in financial statements.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- ▶ where the deferred tax liability arises from the initial recognition of an asset or liability in a transaction which at the time of the related transaction affects neither the accounting profit nor taxable profit or loss; and
- ▶ in respect of taxable temporary differences associated with investments in associates, and interests in joint ventures where timing of the reversal of the temporary difference can be controlled and it is probable that the temporary difference will not reverse in the foreseeable future.

3.13 Taxation (continued)

Deferred tax (continued)

Deferred tax assets are recognised for all deductible temporary differences, carried forward unused tax credit and unused tax losses, to the extent that it is probable that taxable profit will be available against which deductible temporary differences, carried forward unused tax credit and unused tax losses can be utilised, except:

- ▶ where the deferred tax asset in respect of deductible temporary difference which arises from the initial recognition of an asset or liability which at the time of the related transaction, affects neither the accounting profit nor taxable profit or loss; and
- ▶ in respect of deductible temporarily differences associated with investments in associates, and interests in joint ventures, deferred tax assets are recognised only to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Previously unrecognised deferred tax assets are reassessed at each reporting date and are recognised to the extent that it has become probable that future taxable profit will allow the deferred tax assets to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset realised or the liability is settled based on tax rates and tax laws that have been enacted at the balance sheet date.

Deferred tax is charged or credited to the income statement, except when it relates to items recognised directly to equity, in which case the deferred tax is also dealt with in the equity account.

Deferred tax assets and liabilities are offset when there is a legally enforceable right for the Company to offset current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority on:

- ▶ either the same taxable entity; or
- ▶ when the Company intends either settle current tax liabilities and assets on a net basis or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

3.14 Earnings per share

Basic earnings per share amounts are calculated by dividing net profit after tax for the year attributable to ordinary shareholders of the Company (after adjusting for the bonus and welfare fund and Remuneration of the Board of Directors, the Board of Supervision, Management) by the weighted average number of ordinary shares outstanding during the year.

Diluted earnings per share amounts are calculated by dividing the net profit after tax attributable to ordinary equity holders of the Company (after adjusting for interest on the convertible preference shares) by the weighted average number of ordinary shares outstanding during the year plus the weighted average number of ordinary shares that would be issued on conversion of all the dilutive potential ordinary shares into ordinary shares.

3.15 Segment information

A segment is a component determined separately by the Company which is engaged in providing products or related services (business segment) or providing products or services in a particular economic environment (geographical segment), that is subject to risks and returns that are different from those of other segments.

The Company's principal activities are to produce electricity. In addition, these activities are mainly taking place within Vietnam. As a result, the Company's risks and returns are not impacted by the Company's products that the Company is manufacturing or the locations where the Company is trading. Therefore, the Company has one segment by business or geography and presentation of segment information is not required.

3.16 Related parties

Parties are considered to be related parties of the Company if one party has the ability, directly or indirectly, to control the other party or exercise significant influence over the other party in making financial and operating decisions, or when the Company and other party are under common control or under common significant influence. Related parties can be enterprise or individual, including close members of the family of any such individual.

20. CORPORATE INCOME TAX

The corporate income tax ("CIT") rate applicable to the Company is 20% of the taxable income.

Regarding income from original project:

The preferential tax rate of 10% is applied for a period of 15 years from the time the project beginning with the commercial phase (from 2014 to 2028). According to Circular 78/2014/TT-BTC issued by the Ministry of Finance on 18 June 2014, the Company is exempted from CIT for 4 years from the first year of earning taxable income from its main business activities (from 2014 to 2017) and receive a 50% reduction of CIT for the following 9 years (from 2018 to 2026). Accordingly, the Company applies a CIT rate of 5% in current year.

Regarding income from expansion project:

The preferential tax rate of 10% is applied for a period of 15 years from the time the project beginning with the commercial phase (from 2020 to 2034). According to Circular 78/2014/TT-BTC issued by the Ministry of Finance on 18 June 2014, the Company is entitled to an exemption from CIT for 4 years commencing from the first year in which a taxable income is earned (from 2020 to 2023) and receive a 50% reduction of the applicable CIT tax rate for the following 9 years (from 2024 to 2032). Accordingly, the Company applies a CIT rate of 5% in current year.

The tax returns filed by the Company are subject to examination by the tax authorities. As the application of tax laws and regulations is susceptible to varying interpretations, the amounts reported in the financial statements could change at a later date upon final determination by the tax authorities.

Diluted earnings per share amounts are calculated by dividing the net profit after tax attributable to ordinary equity holders of the Company (after adjusting for interest on the convertible preference shares) by the weighted average number of ordinary shares outstanding during the year plus the weighted average number of ordinary shares that would be issued on conversion of all the dilutive potential ordinary shares into ordinary shares.
