 - + The PetroVietnam Machinery - Technology Joint Stock Company is a large-scale public company. On December 20, 2016, the company officially listed its shares on the UpCom market of the Hanoi Stock Exchange under the securities code PVM.
 - + As of March 19, 2021, the company is no longer a state-owned joint stock company.

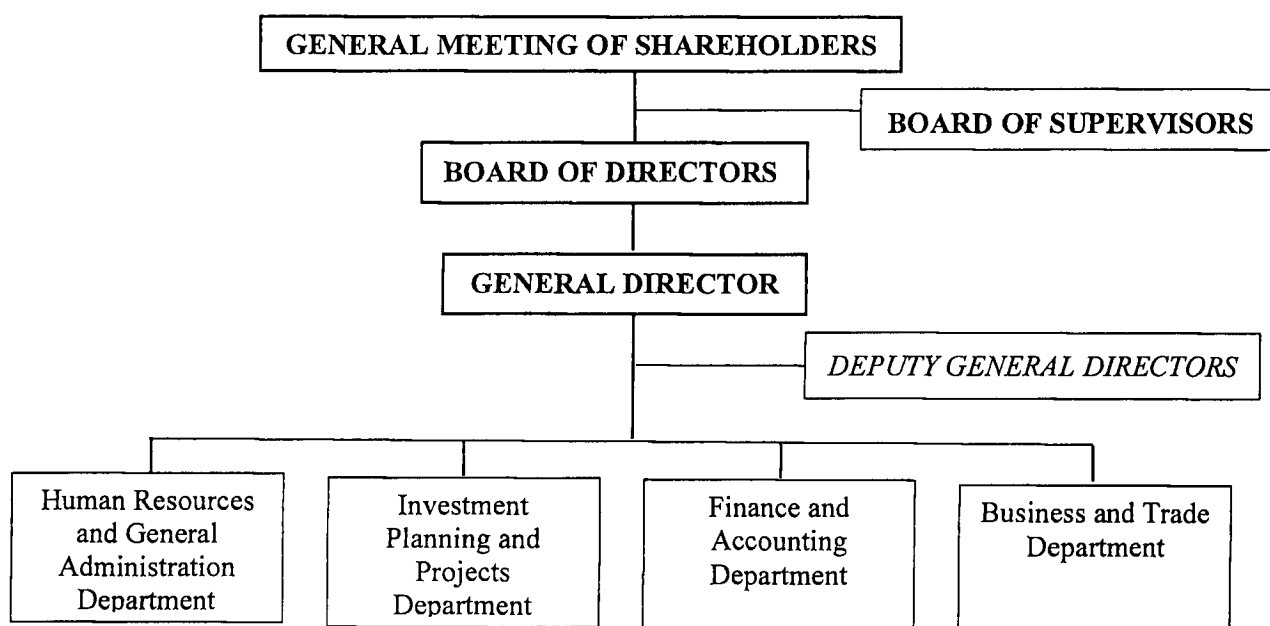

Regarding the 2024 plan targets, the Parent Company achieved the profit target but fell short of its revenue target, the reasons include:

+ Credit limit constraints in the early months of the year, only largely resolved by the end of Q3/2024, leading to a shortage of working capital for business operations in the first half of the year.

+ Business segment and market review activities: The Company discontinued its plastic resin trading segment due to low profit margins.

2. Financial situation.

a) Asset status.

- Current assets at the end of the year increased by VND 149.32 billion (+18.4%) from VND 812.15 billion to VND 961.47 billion, primarily due to:

+ Cash & cash equivalents: Decreased VND 2.57 billion (-10.9%) due to routine payments and supplier obligations

+ Short-term investments: Increased VND 32.52 billion (+40.9%) from growth in term deposits used as collateral for short-term loans supporting production and business activities.

+ Receivables: Surged VND 208.91 billion (+39%), from VND 535.37 billion to VND 744.28 billion, driven by short-term loans and other receivables

+ Inventory: Dropped VND 80.44 billion (-50.7%), from VND 158.53 billion to VND 78.08 billion after selling 13 condominium units (from 2023 inventory).

+ Other current assets: Declined VND 9.1 billion (-60.5%) mainly from reduced deductible VAT by VND 11.81 billion, partially offset by a VND 2.69 billion increase in short-term prepayments.

- Non-current assets decreased VND 99.75 billion (-33.9%), from VND 294.14 billion to VND 194.39 billion, reflecting:

+ Long-term receivables: Fell VND 20.08 billion (-34.8%) from loan repayments

PPE: Increased VND 5.8 billion (+9%) due to capital improvements (VND 7 billion) and equipment purchases (VND 3.7 billion)

Construction in progress: Grew VND 5.16 billion (+30.1%) from ongoing projects

Long-term investments: Reduced VND 88.51 billion (-62.2%) through divestments (VND 103.53 billion total)

Total Assets: Increased VND 49.57 billion (+4.5%) to VND 1,155.86 billion

b) Liabilities Status.

- Year-end liabilities increased by VND 19.65 billion (+4.4%) from VND 447.45 billion to VND 467.1 billion:

+ Current liabilities increased VND 37.93 billion (+9.7%) from VND 392.41 billion to VND 430.33 billion because of the additional borrowing to supplement working capital for production and business operations.

+ Non-current liabilities decreased VND 18.28 billion (-33.2%) from VND 55.04 billion to VND 36.77 billion due to the settlement of matured long-term debt obligations.

3. Improvements in organizational structure, policies, management.

To meet evolving management and business requirements in an increasingly competitive environment, the Company has proactively implemented comprehensive reforms, including organizational restructuring and workforce realignment across all levels. These initiatives are accompanied by new regulations and multi-dimensional policies designed to enhance operational efficiency, reduce costs, optimize profitability, and maintain agility in responding to dynamic market changes – thereby ensuring sustainable growth and long-term development. Specifically:

- Streamlined the organizational structure from 6 specialized Departments/Divisions down to 4 specialized Departments.

- Replaced and appointed competent personnel to the Board of Management with appropriate professional qualifications and practical experience relevant to their assigned fields.

- Reassigned and transferred managerial positions to align with changes in management methods and business orientation; assigned dedicated Capital Representatives of the Company to invested units to enhance the management efficiency of capital contributions to other enterprises.

- Reallocated personnel to implement commercial business segments; Reviewed and reorganized personnel, reducing positions that did not meet job requirements; Conducted employee competency assessments under the spirit of "one person handling multiple tasks" after restructuring and streamlining.

- Complied with internal Regulations/rules; Regularly updated, completed, amended, and supplemented the system of documents and internal management regulations in accordance with current legal provisions; Issued reward and incentive policies to encourage employees to directly participate in finding and implementing effective business solutions.

6. Assessment Report related to the environmental and social responsibilities of the Company .

- Assessment related to environmental indicators: The Company consistently prioritizes measures to enhance working conditions, occupational safety, and hygiene. We maintain a strong commitment to achieving zero workplace accidents and preventing occupational diseases. Regular safety inspections are conducted for machinery, equipment, personal protective gear, and fire prevention/control systems. Employees receive continuous reminders to strictly comply with all occupational safety and health regulations. Furthermore, we implement regular environmental sanitation measures to maintain a Green-Clean-Beautiful workplace.

- Assessment related to labor issues: The Company places utmost importance on occupational health and safety through various initiatives: organizing periodic health examinations for early detection and health consultation; equipping the office with basic medical supplies and first-aid equipment for emergency situations; providing complete personal protective equipment according to job positions; conducting awareness campaigns on occupational health and environmental safety; and strictly adhering to reporting requirements on occupational safety, health, and fire prevention.

- Assessment related to responsibility for the local community: The Company faithfully fulfills its social responsibilities, embodying the traditional values of "When drinking water, think of its source." Throughout the year, we organized various charitable activities in local and disadvantaged areas, including: free

medical check-ups and health consultations for policy families, revolutionary contributors, elderly in difficult circumstances, and poor households in Thai Binh province; financial support for the "Gratitude and Repayment" program organized by Hoan Kiem District People's Committee commemorating the 70th anniversary of the Dien Bien Phu Victory; employee donations to support victims of Typhoon No. 3 in response to the Vietnam Fatherland Front Committee's call; and appreciation gatherings for former leaders and retired employees during Lunar New Year and anniversary occasions; financial support for the elimination of temporary and dilapidated houses in Lang Son province

1. Assessments of the Board of Directors on the Company's main operations.

The company exceeded its approved profit targets, established key business segments after its restructuring phase, and operated in two main areas: (1) Commercial Trading – Defined clear product lines and development strategies. (2) Investment & Project Development – Focused on core projects with implementation plans in place, expecting cash flow generation by late 2024.

- The Company has successfully recovered capital from two investment projects: Commercial housing development project in Thai village residential area, Nguyen Xa commune, Vu Thu district, Thai Binh province and Quan Do Industrial Cluster project, Phu Cu district, Hung Yen province .

- The Company actively and effectively participates in national defense, security, and social order maintenance activities within its operating areas.

- The lives of employees are improved, social security work is carried out in accordance with the policies of the Party and State.

- The Board of Directors and Board of Management continue to focus on comprehensive business development oversight, risk management enhancement, pursuit of new investment opportunities, and strengthening the Company's development capacity based on existing and reinforced internal resources.
