2. Report on the results of shareholder qualification verification and announcement of the percentage of shareholders attending the second Annual General Meeting of Shareholders in 2025

Ms. Nguyen Thi Quynh Trang - Head of the Shareholder Qualification Examination Board reported the results of the shareholder qualification examination to attend the meeting as follows:

- Total number of shareholders at the time of closing the list to conduct the General Meeting of Shareholders as of March 27, 2025 is: 6,316 shareholders, representing 69,329,928 voting shares.;
- As of 8:32 a.m. on May 26, 2025, the number of shareholders present at the General Meeting was 04 shareholders, representing 9,201,569 shares, equivalent to 13.27% of the total number of voting shares.

Pursuant to the provisions of law and the Charter of Quang Binh Import-Export Joint Stock Company on the conditions for holding the General Meeting of Shareholders: The second General Meeting of Shareholders is held when the number of shareholders attending the meeting to 33% of the total number of voting shares (Clause 2, Article 19 of the Charter of Quang Binh Import-Export Company). Currently, the total number of voting shares of the shareholders attending the meeting is lower than the regulations, so it is not eligible to hold the 2025 Annual General Meeting of Shareholders of Quang Binh Import-Export Company.

3. The 2025 Annual General Meeting of Shareholders will be convened for the third time in accordance with the provisions of law and the Charter of Quang Binh Import-Export Joint Stock Company. The Board of Directors will notify the specific time and location later in accordance with the convening procedures prescribed by law../.
