* Explanation for the reasons for the change from profit to loss and the difference in profit and loss of over 10% of profit after tax this year compared to the same period last year.
- Profit after tax in the second quarter of 2025 is: (300.582.224) VND and Profit after tax in the second quarter of 2024 is: 90,645,786 VND, the reason for the change from profit in Q2 of 2024 to loss in Q2 of 2025 is because in Q2 of 2024 there was a provision reversal of: 180,475,658 VND. Q2 2025 management costs are: 302,125,925 VND higher than Q2 2024 management costs so there is a difference in profit and loss of over 10% of this year's period compared to the same period last year.
* Explanation of loss in Q2 2025

In Q2 2025, due to the difficult economic situation, the enterprise had no revenue but still incurred management costs to maintain operations of: 302,125,925 VND, leading to a loss in the business results in Q2 2025.
