In the first 6 months of 2025, the Board of Directors of the Company has operated in compliance with the provisions of the Law on Enterprises and the provisions of law. The Board of Directors directs the Board of Directors to review the issued regulations and develop a number of new regulations to submit to the Board of Directors for consideration and approval and promulgation to apply in accordance with the provisions of law and TKV. In the first 6 months of 2025, the Company's Director has submitted to the Board of Directors for approval the contents of strengthening the Company's management in financial aspects,... In the production and business of the Company; The Party Committee, the Trade Union and the CEO signed Joint Resolutions to unify the leadership and management in all aspects of the movement activities of employees and employees of the Company. Through supervision activities, the Board of Directors assessed:

- The Board of Directors of the Company has strictly implemented the Resolutions and decisions of the Board of Directors; the Regulations and Regulations of Vietnam Coal and Mineral Industry Group and relevant provisions of law. In the process of performing its tasks, the Board of Directors has submitted to the Board of Directors to rearrange the organizational model, re-promulgate regulations in accordance with the State's regulations.

- Regarding cost management: The Company has organized strict control of contracting and cost management to the Workshops in order to strengthen the management and control of costs more and more strictly, increasing the efficiency of mobilizing and using machinery and equipment.

- Construction investment has a focus and focus in order to save investment and promote investment efficiency. The Company's construction investment work strictly complies with the provisions of law, guiding documents of Vietnam Coal and Mineral Industry Group and the Company's Regulation on Construction Investment Management.

- Security and order protection: The Company has developed plans, plans and implemented self-management security, installed cameras at many locations to control coal

warehouses and enter and exit the Company's normal declaration. In addition, the Company also strengthens the protection of mine boundaries, prevents illegal mining, processing and transportation of coal; strengthen patrols and guard and coordinate with the Police force stationed in the area to participate in protecting the Company's assets.

*** Overall Assessment:**

- In the first 6 months of 2025, the Board of Directors has operated production and business and other aspects of the Company's activities in accordance with the law, the direction of the Group, the Resolution and Decision of the Board of Directors of the Company. As a result of the first 6 months of 2025, the Company has successfully completed the main planned targets under the Business Coordination Contract with TKV Group, and the Company has fully fulfilled its obligation to contribute to the state budget.

- Flexible production management process, regularly report to the Board of Directors on arising problems and submit to the Board of Directors for timely settlement of work contents under the approval authority of the Board of Directors. Therefore, all production and business activities of the Company take place normally, without congestion, the Company completes the main targets of the Production and Business Plan in the first 6 months of 2025:

+ Coal production: 924,000 tons (56% of the year plan, 118% over the same period in 2024).

+ Excavation: Implement 10,160 m (53.5% of the year plan, 107% over the same period in 2024). In which: internally implemented 9,250 m (55.7% of the plan, 109.2% over the same period), outsourced 910 m (38.1% of the plan, 88.6% over the same period). The anchor furnace meter is 765 m (76.5% of the plan, 105.4% over the same period in 2024).

+ Coal consumption: Total 898,500 tons (54.5% of the year plan, 114.6% over the same period in 2024).

Revenue: Coal consumption reached 760,400 tons (54.1% of the plan), equivalent to revenue of VND 1,447.4 billion (54.5% of the plan, up 114.4% over the same period). Revenue increased by VND 10.1 billion due to the quality of downstream coal.

- The Company's production and business results after setting aside provisions and purchasing property insurance as prescribed, the profit before tax is VND 18.5 billion, so the Company has preserved and developed capital.
