changes in profit after tax on the Financial Statements of Quarter 3, 2025  
compared to the same period last year, specifically as follows:

- Profit after tax in the Income Statement of Quarter 3, 2025 of IDICO  
Investment Construction Oil and Natural Gas Joint Stock Company decreased  
compared to the same period last year: -45,291 million VND (2,658 million VND  
– 47,949 million VND), in which:

*Profit after tax in Quarter 3, 2024: 47,949 million VND*

*Profit after tax in Quarter 3, 2025: 2,658 million VND*

Reason: Profit after tax in Quarter 3, 2025 decreased compared to the same  
period last year due to the absence of real estate business revenue from the  
Investment and Construction Project of the Commercial, Service, and Residential  
Center in the Bac Chau Giang Urban Area.

The above is the explanation of IDICO Investment Construction Oil and  
Natural Gas Joint Stock Company on the change in profit after tax in the Financial  
Statements of Quarter 3, 2025 compared to Quarter 3, 2024.
