**DECISION**

Subject: Assignment of responsibilities for the Company's Finance and Accounting Department

**DECISION**

**Article 1.** Assigning Mr. Dam Quang Hung – Maritime Transport Economics Engineer – to be in charge of the Finance and Accounting Department and responsible for the finance and accounting of Petroleum Pinline and Tank Construction Joint Stock Company.

Assignment period: 6 months from January 6, 2026
