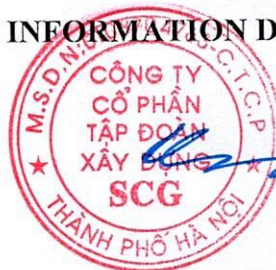

RESOLVES

Article 1. Approval of the execution of an Appendix to the Contract with Sunshine Saigon Group Joint Stock Company (attached to Contract No. 161/2024/HĐTC/SSSG-SCG dated September 30, 2024), specifically:

- 1. Employer:** Sunshine Saigon Group Joint Stock Company ("Sunshine Saigon")
