## **RESOLUTION OF THE BOARD OF DIRECTORS MONG DUONG COAL JOINT STOCK COMPANY - VINACOMIN**

*Pursuant to the Charter of organization and operation of Mong Duong – Vinacomin Coal Joint Stock Company approved by the General Meeting of Shareholders on April 24, 2021;*

*Pursuant to the Operating Regulation of the Board of Directors of Mong Duong - Vinacomin Coal Joint Stock Company approved by the General Meeting of Shareholders on April 24, 2021;*

*Pursuant to the Minutes of the Board of Directors Meeting No. 01/BB-HDQT dated 14/01/2026 of the Board of Directors of Mong Duong Coal Joint Stock Company - Vinacomin.*

### **RESOLVED:**

**Article 1.** The Board of Directors of Mong Duong - Vinacomin Coal Joint Stock Company met to approve the Resolution with the following contents:

**1. Approve and approve the plan to organize the Annual General Meeting of Shareholders in 2026.**

Considering the Draft Plan to organize the Annual General Meeting of Shareholders in 2026. The members of the Board of Directors participated in the discussion and unanimously voted on the Resolution as follows:

1.1. The Board of Directors unanimously approves the Plan to organize the Annual General Meeting of Shareholders in 2026.

1.2. The Board of Directors agreed to establish the Organizing Committee of the 2026 Annual General Meeting of Shareholders of the Company headed by the Director. Members of the Board at the request of the Director of the Company according to the draft Plan and program. The Chairman of the Board of Directors issued a Decision for the Company to organize the implementation.

**2. Through contracts and transactions between Mong Duong Coal Joint Stock Company - Vinacomin and related enterprises and persons**

Considering the Report No. 83/TTr-TMD dated 08/01/2026 regarding the approval of transaction contracts between the Company and enterprises, major shareholders and related persons. Members of the Board of Directors participated in the discussion and unanimously voted on the Resolution as follows:

2.1. Approval of contracts and transactions between the Company and related persons in 2026 under the jurisdiction of the Board of Directors:

- Approval of the list and signing of contracts and transactions: Approve the list of Related Persons of the Company and approve the signing of contracts and transactions within the competence limit of the Board of Directors with the duration of contracts and transactions from 01/01/2026 to the area with other changes (details according to the attached dossier);



- Approval of the policy for arising transactions: The Board of Directors approves the policy, allowing the Director of the Company to carry out actual arising transactions in 2026 (in addition to the above list - if any), ensuring that the transaction value is within the limit of the authority of the Board of Directors. with the following subjects: (i) Other member units under TKV (including newly established, merged or renamed units in the plan year); (ii) Other enterprises in which the Company's Internal Persons are representatives of contributed capital or hold additional management positions shall be additionally appointed in 2026;

Authorization of implementation: Authorize the Director of the Company to actively negotiate and decide on prices (ensuring the principle of market prices and the interests of the Company), sign contracts and disclose information in accordance with the provisions of law.

2.2. Approve the policy to be submitted to the Annual General Meeting of Shareholders (AGM) in 2026 for consideration and approval, specifically as follows:

- Approval of the list and transaction contents: submit to the General Meeting of Shareholders for approval the list of related persons and main transaction contents expected in 2026 under the jurisdiction of the General Meeting of Shareholders (details are in the attached dossier);

- Mechanism to ensure continuous operation and effectiveness: In order to ensure that production and business activities take place regularly, continuously and without interruption while waiting for the General Meeting of Shareholders to meet and issue resolutions, the Board of Directors shall submit to the General Meeting of Shareholders for approval the following mechanisms:

+ Transitional effect: Allow the Company to continue to execute transaction contracts with a time to perform from January 1, 2026 with the above-mentioned entities until there is a new Resolution of the latest General Meeting of Shareholders in 2026 to replace it (ensuring the principle of market price or unit price prescribed by the State/Group).

+ Approval of executed transactions: The General Meeting of Shareholders approves the contracts and transactions with a performance period from 01/01/2026 in the above list that have been implemented until a new Resolution of the latest General Meeting of Shareholders in 2026 replaces them.

\* For contracts and transactions not mentioned in Sections 2.1 and 2.2 above related to related persons that must be declared in accordance with the provisions of the Law on Enterprises 2020: The Company will report to the Board of Directors/General Meeting of Shareholders according to the competent limit when it arises.

2.3. For contracts and transactions not mentioned in Sections 2.1 and 2.2 above related to related persons, declaration must be made in accordance with the provisions of the Law on Enterprises 2020; The Company will report to the Board of Directors/General Meeting of Shareholders for approval according to the competent limit when it arises.

2.4. The Director of the Company shall direct the Internal Persons in the Company to review, declare and periodically report on related persons and interests related to the Internal Persons specified in Article 164 of the Law on Enterprises 2020. The person in charge of corporate governance shall make a wide notice to update and disclose information to relevant persons in the company as prescribed; Update the contract signing report related to the authority of the Board of Directors as prescribed.

**Article 2.** This Resolution takes effect from the date of signing.

**Article 3.** Members of the Board of Directors, Board of Directors, Chief Accountant; Heads of relevant departments in the Company based on the Implementation Resolution./.
