3. Supervision over the Board of Management by the BOD:

In 2025, the BOD has fulfilled its functions and responsibilities as outlined in the Articles of the 36 Corporation, specifically:

- The BOD actively followed the Resolutions of the General Meeting of Shareholders (GMS) to implement the Corporation's business operations accurately and effectively, ensuring the successful execution of the strategies, policies, and measures established. At the

same time, the BOD supervised the Board of Management in carrying out the Resolutions and Decisions made by the BOD.

- The BOD maintained regular meetings as stipulated and held extraordinary meetings when necessary to develop strategies and solutions to address issues related to the development strategy and implementation of business plans. The BOD has issued 70 decisions/resolutions, which were widely agreed upon in BOD meetings and promptly offered effective solutions to overcome challenges during the management of operations by the Board of Management. Specific decisions/resolutions include the following:

- The BOD continuously developed internal mechanisms for monitoring and supervising the operations of the Board of Management through regular and ad hoc meetings of the Executive Committee as necessary, enabling timely decision-making to ensure effective execution of the Corporation's investment and business activities in alignment with the strategic directions approved by the BOD and the General Meeting of Shareholders.

- The BOD enhanced oversight and financial management across the Corporation by strengthening cost control, reducing unnecessary expenses, and avoiding wasteful spending.

Results of Business Operations Oversight

The BOD has led and directed the formulation of the business and production plan for 2025 and assigned specific performance targets to each subsidiary unit. The Board provided strategic direction for the implementation of the plan, focusing on inspection and supervision with clear priorities and emphasis on key projects that are of high value and urgency in terms of progress. The Board also directed the timely preparation and completion of technical documentation, as-built dossiers, A-B settlement reports, internal financial finalizations, and contract liquidation with project investors and among internal units.

Results of job-seeking marketing activities

The BOD has identified job-seeking marketing as a matter of vital importance to the enterprise. The Corporation has leveraged its traditional strengths in civil construction, infrastructure - transportation, and irrigation works, while gradually affirming its position in real estate investment and BOT projects. It has focused its marketing efforts on highly feasible large-scale projects, using clear sources of funding. At the same time, it has expanded its search to the private sector and projects funded by foreign investment (FDI, WB, ODA, JICA), as well as projects implemented under public-private partnership models. Thanks to high-quality bid dossiers with competitive unit prices, the Corporation successfully won the bids and was awarded contracts through direct appointment. In 2024, the Corporation entered into A-B economic contracts for five (05) packages with a total value of VND 497.42 billion, specifically: the package for Expansion of Training Facilities of the Vietnam Women's Academy (VND 47.02 billion); Package TB01: "Supply and Installation of Works Equipment" for Long Thanh Airport (VND 168.73 billion); the package for Anti-Landslide Embankment along the O Mon River - Can Tho City (VND 87.20 billion); the package for Construction and Installation of Equipment for Buon Ho Town General Hospital Project, Dak Lak Province (VND 47.25 billion); and Package No. 01: Construction, Supply and Installation of Equipment for the Administration Building Block - Academy of Finance (VND 147.22 billion).

December 19, 2025 marked a milestone in Vietnam's transportation and construction sectors, when 34 projects nationwide were simultaneously held inauguration and groundbreaking ceremonies. Amid the vibrant momentum of the year-end construction surge,

36 Corporation, honored as a Heroic Labor Unit, proudly implemented five exemplary projects, affirming its outstanding construction expertise and its steadfast commitment to serving society and the Fatherland.

- In 2025, a number of landmark projects were inaugurated, completed, and officially handed over for operation, including the Quang Ninh Post Office; K Hospital Building - Site 1 at 43 Quan Su Street, Hanoi; the Tea Irrigation Area in Tan Linh Commune, Thai Nguyen Province; and the Head Office of the Can Tho Regional Branch of the Vietnam Development Bank. Notably, the 123-meter air traffic control tower constructed by 36 Corporation at the “mega-project” of Long Thanh International Airport now stands tall and commanding, proudly serving as the “all-seeing eye” safeguarding the skies of southern Vietnam. Shaped like a graceful lotus blossom, a symbol of the Vietnamese spirit and character, the structure embodies the fusion of modern technology and craftsmanship of soldier-builders. Under the harsh weather conditions at the construction site, work has continued relentlessly around the clock under the demanding “three shifts, four crews” schedule. Each additional level rising on the tower stands as renewed proof of the project’s capability to conquer the most complex technical challenges. More than the heart and soul of the airport, the air traffic control tower has also become a symbol of 36 Corporation’s new stature, an organization always willing to rise to meet global standards and to lay a solid foundation for the takeoff of Vietnam’s civil aviation industry.

The Board of Management of 36 Corporation has directed the Planning and Tendering Department to advise and propose to the BOD specific mechanisms for job-seeking marketing and securing new projects, with a particular focus on those funded by private capital and FDI. All available resources have been mobilized to execute construction works in compliance with safety, quality, and schedule requirements, thereby strengthening the confidence of higher authorities and project owners while maintaining the Corporation’s brand reputation. The Corporation is continuing to implement and further expand its investment portfolio to improve profitability and ensure sufficient workloads in the coming years, in line with the resolutions adopted by the 2025 Annual GMS.

The Board of Management has worked closely with the BOD in directing and guiding the formulation of operational plans, as well as assigning clear responsibilities to project commanders and functional departments. The 2025 Annual GMS was successfully convened. The Corporation completed and submitted the 2024 Corporate Governance Report to the State Securities Commission of Vietnam and the Hanoi Stock Exchange, and carried out (periodic, extraordinary, etc.) information disclosure in full compliance with the Securities Law. In addition, the Corporation proactively engaged with major and strategic shareholders to update them on its 2025 production and business activities as well as its development strategy for the period ahead.

Results of shareholder and securities-related activities

In 2025, the BOD prepared all required documentation and procedures and coordinated with the Vietnam Securities Depository and Clearing Corporation (VSDC) to finalize the shareholder list for the Annual GMS and to make cash dividend payments from undistributed profits for the 2023 and 2024 fiscal years. The Corporation also reported to the Ministry of National Defense on matters related to state capital and share custody, and issued Decisions on the appointment and dismissal of personnel.
