**RESOLVES:**

**Article 1.** To approve the policy on signing the Economic Contracts and Contract Appendices between Da Nang Port Joint Stock Company and the Branch of Vietnam Maritime Agency Joint Stock Company – Da Nang Maritime Agency, in accordance with the proposal of the General Director of Da Nang Port as stated in Submission No. 191/TTr-CDN dated January 29, 2026.

The Economic Contracts and Contract Appendices include:

1. Appendix to the Container Service Provision Contract, effective from January 1, 2026 to December 31, 2026.
2. Bulk Cargo Handling Service Provision Contract, effective from January 1, 2026 to December 31, 2026.




3. Service Provision Contract for Passenger Vessels and Passenger Vessel Agents, effective from January 1, 2026 to December 31, 2026.

**Article 2.** To assign the General Director, the legal representative of Da Nang Port, to consider, execute, and implement the Economic Contracts and Contract Appendices between Da Nang Port Joint Stock Company and the Branch of Vietnam Maritime Agency Joint Stock Company – Da Nang Maritime Agency, in compliance with applicable laws, the Company's Charter, internal rules and regulations of Da Nang Port, and other relevant regulations; ensuring alignment with market conditions, balancing revenues and costs, guaranteeing efficiency, and generating economic benefits for Da Nang Port; and to carry out information disclosure in accordance with regulations.
