**DECISION**

**Of sanctioning administrative violations on tax**

*Pursuant to Decree No. 57, Decree No. 68, Decree No. 70, Decree No. 78, Decree No. 85 of the Law on Handling of Administrative Violations (as amended and supplemented in 2020);*

**DECIDES:**

**Article 1.** Sanctioning administrative violations on tax of the following taxpayer:

VISSAN JOINT STOCK COMPANY - Tax code: 0300105356

Head office address: 420 No Trang Long Street, Binh Loi Trung Ward, HCM city.

Legal document of juridical person: Certificate of Enterprise Registration of Joint Stock Company, enterprise identification (EID) numbers 0300105356 issued by the Business registration office – Departments of Finance, first registered on October 11, 2006, 44th further amended on August 25, 2025.

2. Administrative tax violation committed: Late submission of non-agricultural land use tax declaration dossiers at 420 No Trang Long (nowadays called Vu Ngoc Phan Street), Binh Loi Trung Ward, Ho Chi Minh City from 2020 to 2021 and from 2022 to 2026 more than 90 days after additional taxes is incurred.

3. Administrative violation stipulated in: Clause 5, Article 13 of Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government, Clause 5 Article 1 Decree No. 310/2025/ND-CP dated December 02, 2025 of the Government amending certain Articles of the Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government.

4. Aggravating circumstances (if any): 01 circumstance.

5. Extenuating circumstances (if any): None.

6. Shall be applicable for penalties and remedial measures as follows:

a) The application of the sanction: Fines.

Fine amounts **22,000,000 VND**

*(In words: Twenty-two million Vietnamese Dong)*

Payment details based on: Chapter 558, Sub-item 4254.

b) Additional penalties (if any): None

c) Remedial measures (if any): None

**Article 2.** This Decision shall be effective from the signing date.

**Article 3. This Decision shall be:**

1. Mr. Le Minh Tuan is the legal representative of the violating organization named in Article 1 of this Decision shall, for execution.

The organization named in Article 1 must strictly complies with this Sanctioning Decision. If past the above-mentioned time limit, VISSAN Joint Stock Company shall be enforced for execution of sanctioning decision.

a) VISSAN Joint Stock Company, the sanctioned organization named in Article 1, must pays the fine into account number 7111.1056137 of the Ho Chi Minh City Tax Office registered at the State Treasury Region II within 10 days after receiving this Decision.

If past the above-mentioned time limit, the organization named in Article 1 shall be enforced for execution of sanctioning decision.

b) VISSAN Joint Stock Company reserves the right to lodge a complaint or file a lawsuit against this Decision pursuant to the law.

2. Pay the fines to the State Treasury Office of Region II./.
