4. Contents of the published information:

The first quarter 2026 financial statement prepared on April 20, 2026 has a difference of more than 10% in profit compared to the same period in 2025 and the after-tax profit arising in the quarter changed from profit to loss in the first quarter of 2026. The Company would like to explain as follows:

The Company's profit after tax in the first quarter of 2026 is -1.29 billion VND, down 1.49 billion VND compared to the same period in 2025, changing from a profit of 201,78 million VND to a loss of 1.29 billion VND in the first quarter of 2026, due to the following main reasons:

- Due to the increase in Cost of Goods Sold/Net Revenue ratio of 1.43%, Gross Profit on sales and service provision decreased by 457.64 million VND, equivalent to a decrease of 8.52% compared to the same period last year.

- Financial activity revenue in the first quarter of 2026 recorded 413.06 million VND, down 203.7 million VND, equivalent to a decrease of 33.03% compared to the same period last year.

- Other expenses in the first quarter of 2026 of the Company recorded 747.88 million VND, equivalent to an increase of 747.88 million VND compared to the same period last year.

Therefore, the Company's profit after tax in the first quarter of 2026 was recorded at -1.29 billion VND, down 1.49 billion VND, equivalent to a decrease of 738.33% compared to the same period in 2025 and changed from a profit of 201.78 million VND to a loss of 1.29 billion VND in the first quarter of 2026.
