Hoang Ha Joint Stock Company would like to provide an explanation for the reasons behind the after-tax profit in the separate and consolidated financial statements for Quarter 1 of 2025 showing a loss and being higher than that of Quarter 1 of 2025, in accordance with Circular No. 155/2015/TT-BTC dated October 06, 2015, issued by the Ministry of Finance, providing guidelines on information disclosure in the securities market, as follows:

- After-tax profit in the separate financial statement for Quarter 1 of 2025: (50.719.708.727) VND.

- After-tax profit in the separate financial statement for Quarter 1 of 2026: (3.220.153.234) VND.

And:

- After-tax profit in the consolidated financial statement for Quarter 1 of 2025: (50.728.156.534) VND.

- After-tax profit in the consolidated financial statement for Quarter 1 of 2026: (3.222.903.270) VND.

The after-tax profit in the separate and consolidated financial statements for Quarter 1 of 2026 shows a loss and is higher than that of Quarter 1 of 2025, primarily due to the following reasons:

+ Following the prolonged COVID-19 pandemic, the operations of the transportation sector have not yet fully recovered to their previous levels. Revenue remains low, while the company's costs, including fixed asset depreciation, remain unchanged.

+ There was no revenue from real estate brokerage activities.

The above is the explanation regarding the after-tax profit in the separate and consolidated financial statements for Quarter 1 of 2026 showing a loss and being higher than that of Quarter 1 of 2025.
