2. Meetings of the Board of Directors

In 2026, NCB's Board of Directors held meetings to make key decisions, provide orientations, and direct NCB's operations from time to time; and to consider and decide on matters and issues falling within the decision-making authority of the Board of Directors (*Appendix 1*).

3. Supervising the Board of Management by the Board of Directors

The supervision by the Board of Directors over the Board of Management is carried out in accordance with the law and NCB's internal regulations and rules, specifically through the following activities:

- Regarding the control environment: NCB's Board of Directors for the 2025–2030 term consists of 8 members, including 2 independent members and 1 member who concurrently acts as an executive, ensuring a structure compliant with the law. The members of the Board of Directors for the 2025–2030 term are experienced personnel with strong banking governance capabilities, satisfying the standards and conditions applicable to members of the Board of Directors under the law and NCB's Charter. Immediately after being elected to the Board of Directors for the 2025–2030 term, the Board of Directors held a meeting to elect the Chairperson and Vice Chairperson of the Board of Directors, and the Chairperson issued decisions assigning duties to each member of the Board of Directors and setting out the Board's specific activity plan for 2026. At the same time, the Board of Directors for the 2025–2030 term also issued resolutions to consolidate the structure of the Committees and Councils under the Board of Directors, which advise the Board on certain areas in the Board's high-level supervision and management over the Chief Executive Officer.

- In the first six months of 2026, the Board of Directors approved and issued various policy documents on the Bank's governance and operations, ensuring compliance with the Circulars guiding the Law on Credit Institutions and alignment with the Bank's development strategy.

- The Board of Directors receives information and reports from the Board of Management on a periodic and ad hoc basis to serve its direction, supervision, and assessment of the effectiveness of the Chief Executive Officer's management activities; and performs its high-level supervisory role over internal control, risk management, and capital adequacy assessment. The Board of Directors issues risk management policies, compliance policies, and other internal regulations; and supervises the Chief Executive Officer in implementing risk prevention measures, organizing control activities, maintaining a control culture and professional ethical standards, and addressing and remedying shortcomings and limitations,...

- The Board of Directors holds thematic meetings, regular briefing meetings, and six-month review meetings with the Board of Management. The Board of Management reports to the Board of Directors on the implementation of resolutions and decisions of the General Meeting of Shareholders and the Board of Directors; the implementation status and business performance results of the past period and the implementation plan for the following period; and certain thematic reports as requested by the Board of Directors, focusing on business performance, risk management, and compliance control. At these meetings, the Board of Directors analyzes, evaluates, and provides directional instructions to the Board of Management to ensure proper implementation of the assigned business targets and plans, while also ensuring the safety of banking operations.

- The Board of Directors has supervised and directed the Board of Management in implementing all aspects of NCB's operations in accordance with the orientations, objectives, and strategy; and the Board of Management has closely followed such objectives and orientations and fully performed the tasks assigned by the General Meeting of Shareholders and the Board of Directors.

4. Activities of the Board of Directors' subcommittees

NCB has 5 Committees and Councils under the Board of Directors, including: the Human Resources Committee, the Risk Management Committee, the Credit Committee, the Technology & Digital Transformation Committee, and the Risk settlement council. The establishment of these Committees and Councils complies with the law, the Charter, and the Bank's internal regulations. The Committees and Councils operate in accordance with the Regulation on Organization and Operation of each Committee or Council issued by the Board of Directors. Of which:

(i) Human Resources Committee:

The Human Resources Committee consists of 3 members. In its advisory and consultative role to the Board of Directors on organizational structure, personnel structure, personnel policies, and salary and remuneration matters in the Bank's governance process, in the first six months of 2026, the Human Resources Committee held 16 meetings, including 15 in-person meetings and 1 matter for written consultation, to advise and consult the Board of Directors on the following matters:

- Recruitment, arrangement, and appointment plans for key personnel positions;
- Review and completion of the organizational and personnel structure across the entire system;
- The 2026 salary adjustment plan;
- Results of performance assessment and ranking, reward system, recognition of outstanding individuals, and the plan for payment of 2025 performance bonuses;
- Remuneration and benefit policies for NCB employees.

(ii) Technology & Digital Transformation Committee:

The Technology & Digital Transformation Committee has an advisory role to the Board of Directors on technology development orientations and technology applications to enhance governance and management capacity and promote the Bank's business efficiency. In the first six months of 2026, the Technology & Digital Transformation Committee held 3 regular meetings at the request of the Chairperson of the Technology Committee, to advise and consult the Board of Directors on the following matters:

- Reviewing, enhancing, and completing security systems, databases, and NCB's documents, regulations, and procedures on information security, ensuring compliance with legal regulations and the Bank's practical requirements;
- Conducting an overall review and supervising the implementation of the Bank's key projects, including Data Platform, Super App, AML, T24 Modernization, Visa Click to Pay, TX upgrade and connection with Visa, Biometrics System, etc.;
- Reviewing and assessing the capacity of contractors/partners during the implementation of the Bank's key technology projects;

(iii) Credit Committee:

The Credit Committee considers, proposes, appraises, and advises the Board of Directors on the approval of credit facilities falling within the authority of the Board of Directors. In the first six months of 2026, the Credit Committee held meetings and submitted credit facilities/adjustments to credit facilities falling within the decision-making authority of the Board of Directors for approval by the Board of Directors¹.

¹ In the first six months of 2026, the Credit Committee advised and submitted 92 credit dossiers falling within the authority of the Board of Directors for consideration and approval by the Board of Directors.

(iv) Risk Management Committee:

In its role of advising the Board of Directors on risk management matters, in the first six months of 2026, the Risk Management Committee held 3 meetings and conducted written consultations on the following matters:

- Advising the Board of Directors on the issuance of the risk appetite; supervising the implementation of the risk appetite and risk limits.
- Reviewing and giving opinions on the Report and proposal on stress-testing scenarios for capital and the capital plan;
- Supervising the implementation of sub-projects to enhance risk management capacity and strengthen the internal control system at NCB;
- Reviewing, assessing, and giving opinions on the strengthening of compliance control and supervision at the Bank; the development of NCB's internal credit rating system; and the optimization of risk-weighted assets (RWA) in the Bank's business operations.
- Reviewing, assessing, and giving advisory opinions to the Board of Directors on the handling of the Bank's investments.

(v) Risk Settlement Council:

The Risk settlement council held meetings to review and approve, within its authority, dossiers on debt classification, risk provisioning, debt resolution plans, collateral resolution plans, legal proceedings measures, and other related matters; and advised on and submitted risk resolution plans falling within the authority of the Board of Directors to the Board of Directors for approval. In the first six months of 2026, the Risk settlement council reviewed and gave opinions on 46 risk resolution dossiers/plans, including 13 risk resolution dossiers/plans which it advised on for submission to the Board of Directors for approval within its authority.

In addition to the above meetings, the Board of Supervisors regularly exchanged information and obtained written opinions to decide on matters falling within the authority of the Board of Supervisors and to direct the activities of the Internal Audit Center.

3. Supervising Board of Directors, Board of Management and shareholders by Board of Supervisors or Audit Committee

- In the first six months of 2026, the Board of Supervisors supervised compliance with laws, internal regulations, NCB's Charter, and resolutions and decisions of the General Meeting of Shareholders and the Board of Directors in governance and management activities, specifically as follows:
 - + Supervising the Board of Directors in implementing the resolutions and decisions of the General Meeting of Shareholders, and in implementing the 2026 business orientations and targets approved by the Annual General Meeting of Shareholders on 2 April 2026;
 - + Supervising the Chief Executive Officer in implementing the directions, resolutions and decisions of the Board of Directors;
 - + Supervising the Board of Directors and the Chief Executive Officer in the timely and full implementation of the policies, directions and instructions of the Government and the State Bank of Viet Nam.

- Attending meetings of the Board of Directors and the Board of Management in accordance with regulations.
- Supervising the implementation of the Regulation on Enhanced Supervision and directing the Internal Audit Center to review credit facilities valued at VND 50 billion or more; the Internal Audit Center acts as the focal point for consolidating reports on capital contribution and share purchase transactions, receivables, and investment transactions in the form of capital contribution or share purchase for the purpose of acquiring control over enterprises valued at VND 50 billion or more.
- Supervising the implementation results of recommendations stated in inspection conclusions.
- Supervising the implementation of the Restructuring Plan;
- Preparing quarterly supervision and risk warning reports on NCB's business operations and sending them to the Board of Directors and the Board of Management. The Board of Supervisors supervised NCB's financial status, the disclosure of periodic Financial Statements, and periodic reports on the Bank's governance in accordance with regulations on information disclosure on the securities market applicable to listed organizations.
- Supervising compliance with prudential limits and restrictions in NCB's operations in accordance with the Law on Credit Institutions.
- Supervising the approval and implementation of investment projects, purchases and sales of fixed assets, and other contracts and transactions of NCB falling within the decision-making authority of the General Meeting of Shareholders and the Board of Directors; preparing and submitting assessment reports and recommendations on these matters to the Board of Directors and the General Meeting of Shareholders at the nearest General Meeting.
- Performing other tasks in accordance with the Law on Credit Institutions and the Law on Enterprises. The Board of Supervisors monitored and updated the list of shareholders owning 1% or more of charter capital, and related persons of members of the Board of Directors, members of the Board of Supervisors, the Chief Executive Officer, and shareholders owning 1% or more of charter capital.

4. the coordination among the Board of Supervisors, Audit Committee, the Board of Management, Board of Directors and other managers:

- The Board of Directors, the Board of Supervisors and the Board of Management regularly exchanged information relating to the Bank's operations.
- In implementing NCB's Internal Governance Regulation, the Board of Supervisors received documents for meetings of the Board of Directors, documents for written consultation with the Board of Directors, resolutions, and minutes of meetings of the Board of Directors. The Board of Supervisors was also provided by the Chief Executive Officer with reports on operational status and business results; and reports, dossiers, and documents relating to the Bank's business, management, and administration activities upon request.
- The Board of Supervisors attended meetings of the Board of Directors, regular briefing

meetings between the Board of Directors and the Board of Management, and meetings of the Risk Management Committee to serve the audit and supervision duties of the Board of Supervisors. The opinions of the Board of Supervisors were considered and implemented by the Board of Directors and the Board of Management, ensuring NCB's interests and compliance with the law and the Bank's internal regulations.

- Based on internal audit results and the review of internal documents, the Board of Supervisors sent management letters/official letters and recommendations to the Board of Directors and the Board of Management, requesting the Board of Directors and the Board of Management to direct the audited units to seriously remedy the shortcomings identified in the recommendations of the Board of Supervisors/Internal Audit, correct deficiencies, and revise internal documents and procedures in order to improve the effectiveness of internal control. The Board of Management received these recommendations and promptly issued directions and urged the units to make corrections in accordance with the recommendations of Internal Audit, remedy shortcomings, amend and complete internal documents, and implement the recommendations of the Board of Supervisors, thereby minimizing risks, ensuring compliance with legal regulations and NCB's Charter, and contributing to improving the quality, efficiency, and safety of NCB's operations.
- Before approving the 2026 internal audit plan, the Board of Supervisors consulted the Board of Directors and the Chief Executive Officer for the purpose of developing a practical internal audit plan that ensures risk coverage. The Board of Supervisors also notified the Board of Directors and the Chief Executive Officer of the 2026 internal audit plan so that the Chief Executive Officer could direct the relevant units to prepare for the audit plan.

5. Other activities of the Board of Supervisors and Audit Committee (if any):

- In the first six months of 2026, the Board of Supervisors carried out the following activities:
- Proposed and recommended that the Annual General Meeting of Shareholders approve the independent audit firm to audit/review NCB's financial statements and internal control system for 2027;
- Appraised the 2025 financial statements and assessed the reasonableness, legality, truthfulness, and prudence in accounting, statistics, and preparation of financial statements.
- Directed the Internal Audit Center to perform its duties in accordance with NCB's Charter, the Regulation on Organization and Operation of the Board of Supervisors, and the 2026 internal audit plan.
- Directed the Internal Audit Center to conduct 8 thematic audits at NCB's divisions, departments, units, and branches in various areas, including treasury operations, anti-money laundering, access rights management, factoring products, guarantee products, retail housing loans at NCB, and the centralized procurement process for non-recurring goods and services.
- Submitted to the General Meeting of Shareholders for consideration and approval the

amended and supplemented Regulation on Organization and Operation of the Board of Supervisors in accordance with the new provisions of Circular No. 83/2025/TT-NHNN.

- Directed the Internal Audit Center to review, amend, complete, submit to the Board of Supervisors for approval, and issue decisions promulgating the following internal documents:
 - + The amended and supplemented Internal Audit Regulation in accordance with the new provisions of Circular No. 83/2025/TT-NHNN.
 - + The Regulation on Professional Ethical Standards and supervision and assessment of compliance with professional ethical standards by members of the Board of Supervisors and internal auditors of NCB, ensuring compliance with relevant laws and regulations.
- Supervised and assessed the implementation by units of recommendations made by the Board of Supervisors and Internal Audit.

VI. Training courses on corporate governance:

In the first six months of 2026, the Bank focused on organizing training programs for its management personnel, covering the following main areas:

1. Training on digital transformation, technology and data application

In the context of promoting digital transformation, the Bank focused on equipping its management personnel with knowledge and skills in applying technology to management, administration and business operations. Typical programs included:

- Advanced AI for Credit appraisal;
- Advanced AI for collateral appraisal;
- AI application in slide design;
- Advanced AI application in control and internal audit optimization of the Bank's operation;
- BigQuery;
- Data analysis and visualization with Looker Studio.

2. Đào tạo nghiệp vụ, quy trình cho cán bộ quản lý tại Đơn vị kinh doanh

Due to system-related requirements, the Bank placed particular emphasis on training in operations and procedures for management personnel at Business Units. Management personnel were required to participate in training together with employees in order to firmly understand procedures and operations, strengthen coordination with support units, and thereby improve work control effectiveness. Training programs on operational procedures and system software accounted for nearly 70% of the total training content of this group.

3. Training on legal compliance and risk management

Training on compliance and risk management continued to be emphasized in order to enhance the awareness, responsibility, and risk management capacity of the management team. Programs implemented included:

- 2026 operational risk management training program;
- Legal matters on credit institutions relating to credit-granting activities for corporate customers;
- Legal matters on real estate investment projects;
- Law on Electronic Transactions;
- Legal training for individual customers and corporate customers;
- Training on the 2025 Law on Personal Data Protection and Decree No. 356/2025/ND-CP dated 31 December 2025 detailing a number of articles and measures for implementation of the Law on Personal Data Protection.

4. Training on management skills, team development, and enhancement of sales effectiveness

In addition to professional training programs, the Bank focused on developing management skills, internal training, and effective exploitation of customer portfolios for management personnel, including:

- Training of internal trainers in the Customer Service segment;
- Skills in understanding and effectively exploiting customer portfolios.
