3. Supervising Board of Directors and shareholders by Supervisory Board:

During the first 6 months of 2026, the SB strengthened its inspection and control activities, coordinating with the BOD and the Board of Management to closely monitor the implementation and evaluate the results of the resolutions of the GMS and the BOD.
