Based on the audited 2026 Interim Financial Statements, IDICO  
Investment Construction Oil and Natural Gas Joint Stock Company would like  
to explain the changes in profit after tax on the 2026 interim financial report has  
been reviewed compared to the same period last year, specifically as follows:

- Profit after tax in the audited 2026 Mid-Year Business Performance  
Report of IDICO Petroleum Construction Investment Joint Stock Company  
decreased compared to the same period last year: -121,204 million VND (22,331  
million VND – 143,535 million VND), in which:

*Profit after tax for the first 6 months of 2025: 143,535 million VND*

*Profit after tax for the first 6 months of 2026: 22,331 million VND*

Reason: Profit after tax declined due to low revenue from real estate sales at  
the commercial, service, and residential complex project within the Bac Chau  
Giang Urban Area, as well as the absence of one-off revenue from the leasing of  
infrastructure at the My Xuan B1 Industrial Park.

The above is the explanation of IDICO Investment Construction and  
Petroleum Joint Stock Company on the change in profit after tax in the Audited  
interim financial statements for 2026 compared to the same period last year
